University Tour
Terms of Service

The participant acknowledges receiving, reading and agreeing to the terms and conditions set forth below covering the university tour to be provided by Academic Ventures, LLC.

1. **Scope.** Academic Ventures, LLC provides college university tours for high school students and their guardians, arranging transportation (through a third party motor carrier) to and from the university. Academic Ventures, LLC manages the tour, which allows students to tour the campus according to the tour itinerary provided to the participants (however, such itinerary is subject to change and does not form a part of this contract).

2. **Fees/Payment.** Payment must be received to secure a reservation for the tour. Fees are subject to change up to the time of payment. Prices do not include any applicable sales or other taxes required by law. Returned checks are subject to a service fee of \$50.00.

3. **Schedule Changes.** Participant acknowledges that original tour dates may be changed or cancelled due to weather conditions, rescheduling by the university or other reasons. All reasonable efforts will be made to re-schedule the tour.

4. **Refunds/Cancellations.** If participant chooses not to participate in the tour, or can not participate in the tour for whatever reason, no refunds will be given once payment has been accepted by Academic Ventures, LLC. No refunds will be provided if participant does not arrive on time for departure, either from the originating point or from the university. No refunds will be provided unless the tour is cancelled and cannot be re-scheduled.

5. **Force Majeure.** Academic Ventures, LLC shall not be liable for delays or for other failure to perform due to causes beyond its reasonable control, including, but not limited to, force majeure and acts of God.

6. **Guardians.** Academic Ventures manages the tour but does not serve as guardian to any of the participants. Parents and guardians are responsible for the conduct of the participants. All participants are expected to follow all applicable campus rules and behave responsibly.

7. **Transportation.** Academic Ventures will contract with a third party motor carrier to provide transportation service to the university. In no event will Academic Ventures, LLC be liable for the acts or omissions of the third party motor coach company and operator.

8. **Limitation of Liability.** Academic Ventures, LLC is not responsible for personal injury, property damage or loss, or any other claim (except to the extent caused by Academic Ventures, LLC's negligence).

9. **Disputes.** All unresolved disputes concerning or in connection with the services provided by Academic Ventures, LLC shall be resolved in the state Court of Common Pleas of the State of Ohio, Cuyahoga County. Participant consents and agrees that jurisdiction and venue for such proceedings shall lie exclusively with such courts.

10. **General.** The exercise or failure to exercise any remedy shall not preclude the exercise of that remedy at another time or of any other remedy at any time. If any provision or portion of this contract is held to be invalid, illegal, unconscionable or unenforceable, the other provisions and portions shall not be affected.
